

AIA Triangle PRIVACY POLICY

PROTECTING YOUR PRIVATE INFORMATION IS OUR PRIORITY.

This Statement of Privacy applies to aiatriangle.org, aiatrianglelf.com, triangleyaf.com, aiatriangleawards. com, aiatriangleawards.org, aiatriangletour.com, aiatriangletour.org and AlA Triangle and governs data collection and usage. The AlA Triangle website is primarily a news and information site with information about the organization and its events as well as an ecommerce site which sells event tickets, membership to the organization and more. By using the AlA Triangle website, you consent to the data practices described in this statement.

COLLECTION OF YOUR PERSONAL INFORMATION

In order to better provide you with products and services offered on our Site, AIA Triangle may collect personally identifiable information, such as your:

- First and Last name
- E-Mail Address
- Phone Number
- Employer
- Job Title

If you purchase AIA Triangle's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

SHARING INFORMATION WITH THIRD PARTIES

AlA Triangle may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to AlA Triangle, and they are required to maintain the confidentiality of your information.

AlA Triangle may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) confirm the edicts of the law or comply with legal process served on AlA Triangle or the site; (b) protect and defend the rights or property of AlA Triangle; and/or (c) act under exigent circumstances to protect the personal safety of users of AlA Triangle, or the public.

AUTOMATICALLY COLLECTED INFORMATION

Information about your computer hardware and software may be automatically collected by AIA Triangle. - Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
